The CEC/ICMC 2011 Conference

All booths will be 10' wide by 10' deep. Each booth will be equipped with 3' high fabric side rails with 8' high fabric backwall, and a 7" x 44" identification sign. **The Exhibit Hall is carpeted.**

Payments will be accepted by Visa, MasterCard, Discover, checks or bank wire. Checks must be in U.S. dollars drawn on a United States bank and made payable to CEC/ICMC 2011. Bank wire transfer fees are the full responsibility of the exhibiting company.

All payments must be received in full by **April 1, 2011**. Partial payments WILL NOT be accepted. Exhibit Application & Contract Agreements WILL NOT be processed without full payment.

Exhibitor Registration

Each 10' x 10' exhibit booth fee includes one Full Conference registration, two Exhibit Hall Only registrations and one issue of the Transactions of the Cryogenic Engineering Conference for the CEC and the ICMC. Full Conference attendees may attend all technical sessions, exhibits and social events. Exhibit Hall Only registration includes admission to the Exhibit Hall, the Welcome Reception, the Exhibitor Reception and the Refreshment Breaks ONLY.

Additional company personnel are encouraged to attend. Individuals may attend as either additional Full Conference attendees or as "Exhibit Hall Only" personnel. Those wishing to attend CEC/ICMC 2011 technical sessions and social events must indicate Full Conference on the Exhibit Application & Contract Agreement (registration fees will be made available on the CEC/ICMC 2011 website February 1, 2011). Companies will be invoiced for these additional Full Conference registration fees.

Any "Exhibit Hall Only" personnel must register at the \$95 rate on the Exhibit Application & Contract Agreement. This rate includes admittance ONLY to the Welcome Reception, Exhibitor Reception, and Refreshment Breaks. It does not include access to the technical sessions, banquet event or the issue of the Transactions of the Cryogenic Engineering Conference for the CEC or the ICMC.

Assignment of Booth Space

Application & Contract Agreements are date-stamped upon receipt ONLY if payment is accompanying the contract. If payment is received at a later date, the application & contract agreement will be date stamped on the day the payment is received. Exhibit space will be assigned on a first-come, first-served basis (based on the date stamps) until sold out. Booth number assignments, however, will not be made available on the CEC/ICMC 2011 website until April 8, 2011. Once assignments are posted online, an email will be sent to all exhibitors registered.

To select your preferred booth area, please refer to the tentative exhibit floor plan. Exhibitors wishing to avoid assignment of space adjacent to, or across from, particular companies should indicate so on the Exhibit Application & Contract Agreement. Careful consideration will be given to such requests whenever possible. Exhibit Manager reserves the right to adjust floor layout.

Cancellation

If written notice of cancellation is received by **April 1, 2011**, an administrative fee of 20% of the total booth fee will be retained. Cancellations after April 1, 2011 will result in forfeiture of the exhibit fee.

Decorator and Exhibit Service Kit

GES is the official decorator for the CRYO EXPO 2011 and will provide the official exhibit service kit for the exhibit. The exhibit service kit will contain all necessary information required for ordering services from GES and all other selected ancillary suppliers. Also included are any management materials such as event rules, information bulletins, etc. Exhibit service kits will be emailed to all contact persons as noted on the contract agreement and will also be made available online on the GES website on **April 13, 2011**.
