

GRAND COULEE DAM TOUR

MONDAY, JUNE 13, 2011



DEADLINE TO REGISTER:

5:00 PM, MST, Monday, April 25, 2011

A technical industrial tour to Grand Coulee Dam has been arranged for Monday, June 13, 2011. This tour can accommodate a **maximum of 24 participants** and has been arranged exclusively for CEC-ICMC'11. This is a technical tour; therefore, only paid participants of CEC-ICMC'11 may attend. **Companions and children of attendees may not attend.**

The Grand Coulee Dam tour will take approximately 2 hrs. Tour participants will be provided with an overview of the famous Grand Coulee Dam. The history, construction and significance of this magnificent structure will be discussed. The tour will feature two of Grand Coulee's powerhouses and time allowing, a view from the top of the dam. Participants will view the 600 megawatt generators in the third power plant and see the gigantic stainless steel shafts. The tour will finish at the visitor center where participants will be able to view the exhibits at their leisure.

Transportation will be provided, departing and returning to the Spokane Convention Center. The drive to/from the dam will take approximately 2 – 2.5 hours **each way**. Although lunch at a local restaurant near the dam will be provided following the tour, we recommend that you bring bottled water and snacks.

Security measures at Grand Coulee Dam require that citizens of the United States of America provide their name, contact information and driver's license number. Citizens of other countries must provide their name, country of origin and passport number. In both cases, **and without exception**, this information **MUST** be received by Centennial Conferences no later than 5:00 pm MST on Monday, April 25, 2011. Citizens of the U.S. are required to present their U.S. Driver's License to the Centennial Conferences staff person at the bus, prior to boarding. Non U.S. Citizens are required to present their passport to the Centennial Conferences staff person at the bus, prior to boarding. This is a ticketed tour; therefore, all participants will be required to pick up their registration materials and tour ticket on Monday morning between 7:00 am – 7:30 am. More information to come.
